Buyer certifies that he/she is buying this dog for him/herself, to keep, nurture and cherish for the entire lifetime of the dog, and is not acting as an agent for another party.

The first seven letters of this dogs AKC registered name will be INTATTO. Buyer agrees to AKC register this dog to his/her own self within 60 days of purchase.

This dog is being sold in good health. If a veterinarian issues a written statement that the dog is not in good health, the dog may be returned to Seller within 72 hours of the time of receipt. Seller warrants this dog against fatal or crippling heritable disorders for the first year of its life. Should a heritable disorder be found Buyer will furnish written proof of such condition along with a certificate of spay/neuter signed by a licensed veterinarian. Then and only then, will Seller replace it with another of the same sex and equal or better quality minus any shipping fees when one becomes available. Entropion can be caused by factors other than genetics therefore Seller offers no warranty against it. Chow Chows are listed as a brachycephalic breed, therefore Seller offers no warranty against it. Bite is not guaranteed to be scissors or level. Vaccinations are known and/or suspected to cause many health problems including but not limited to skin and joint disorders therefore Buyer agrees to never vaccinate this dog for anything other than parvo, distemper, rabies, and to never vaccinate the dog after it reaches the age of one year except for rabies according to law. Violation of this agreement voids the health warranty in its entirety. NO REPLACEMENT GIVEN IF DOG HAS BEEN OVER VACCINATED. NO REPLACEMENT GIVEN IF DOG HAS BEEN BRED.

This dog is being sold as a show prospect. At time of sale it does not display any disqualifying faults. Should it later become non show quality due to genetic faults Seller will replace it so long as the dog has not been bred and Seller agrees the dog is no longer show quality. Buyer agrees to x-ray the dog at age 24 months for hip and elbow deformities. X-rays will be sent to the OFA for certification. Any expenses involved with this will be the responsibility of the Buyer. If the dog fails any of said tests it must be spayed/neutered. After sending proof of test results and proof of spay/neuter Seller will replace the dog with one of equal or better quality as soon as one becomes available minus any shipping expense. No refund will be given. NO REPLACEMENT GIVEN IF DOG HAS BEEN BRED.

If this animal is to be used for breeding it will not be bred until Buyer has obtained AKC conformation champion status on the dog, Buyer will use great discretion in selecting only bitches/dogs that conform to the AKC standard and that are registered by American

Kennel Club and that they do not have any disqualifying faults or major faults. Buyer is aware of potential damages to Intatto bloodlines if at any time in this dog's life offspring from any litters he/she may have are sold to commercial outlets such as Pet shops or Puppy Mills or Brokers. Seller can and will collect damages of not less than \$3,000.00 per puppy sold to such establishments.

Stud/breeding rights are retained by Seller for use on any female(s) of Seller's choice for a total of no more than two litters consisting of at least two live puppies per litter. Buyer agrees to have semen properly collected, chilled and shipped to Seller by a qualified veterinarian of Buyer's choice within two days notification. Seller is responsible for fees incurred for the collection and shipping of semen. No stud fee will be paid. The dog is to remain sexually intact until this portion of the contract has been fulfilled.

In the event that the Buyer wishes to sell this dog at a later date, the Seller will have a 7 day right of first refusal. It is also agreed that the Buyer will not have the dog destroyed for any reason other than extreme illness. The dog shall not be left at a shelter, Humane Society, or rescue. If for any reason, at any time, the Buyer decides to not keep the dog, he/she may return the dog to the Seller. If this dog is returned to the Seller for any reason, the signed AKC registration or application for registration and signed supplemental transfer form transferring ownership to the Seller will accompany the dog. No refund or replacement will be given.

This dog is to be kept in a healthy environment, supplying good food and shelter and proper veterinary care. This dog is not to be kept on a chain or a rope at anytime and should have a fenced yard or be walked on a regular basis. The Seller shall be entitled to repossess this dog if evidence is provided that this dog is receiving inhumane treatment. No refund or replacement will be given.

Release of Liability and Indemnification

In purchasing this dog, I agree that I am to be solely responsible for this dog and to indemnify and hold Intatto Chow Chows, and Lisa Celli, and any employees of Intatto Chow Chows or Lisa Celli, harmless from any and all claims of liability for the conduct of this dog on and after the date of this contract. I further agree and intend that this release of liability and indemnification shall apply to all known, unknown and unanticipated damages resulting from my purchase, ownership and control of such animal.

Buyer agrees that he/she will pay for all costs and attorney fees of any litigation arising from the sale of this dog, and that the sale is taking place within the state of Texas and is subject to Texas law.
